- 1. <u>Standard Ministry Schedule:</u> Sponsor is aware that Restoration Life Ministries sends Tony & Kim out as a team. Depending on the ministry setting and circumstances, Tony may require a larger team (eg: our intercessors or a ministrel) to accompany him, based on his discretion. The provisions below have been set based upon this 'standard ministry schedule.' Any portion of a day counts as a full day.
- 2. <u>Ministry Support</u>: The ministry support has been set based upon meeting the needs of the ministry. (Please indicate your preference by initialing one below.)

- 3. <u>Deposit & Payment:</u> All ministry support shall be paid by Sponsor in US funds. A non-refundable deposit may be required and shall accompany this signed Agreement. The agreed provision (see above) shall be payable to "Tony Martino" and given to ministry coordinator* before or after the event.

 *Tony does not directly handle ministry funds in order to keep ministry and financial support independent of each other.
- **4.** <u>Expenses:</u> Sponsor agrees to provide and pay for all round-trip airfares, ground transportation/rental cars, meals, hotel accommodations*, and any other expenses occasioned by the ministry time, for Tony & Kim.
- *We consider it very important that appropriate hotel accommodations be provided in order to have an environment that is conducive to proper rest. As such we ask that Sponsor provide a room at a preapproved hotel. In rare instances, accommodations in host homes may be required. Such arrangements must be approved in advance.
- **5.** <u>Travel Arrangements:</u> Sponsor further agrees to coordinate all travel arrangements through the ministry coordinator. We will research for flights and hotels that are best suited for our schedule and needs and are faithful to search for the best "deals." The ministry coordinator can either ask for the Sponsor's credit card information to complete booking or the total airfare can be reimbursed by Sponsor within the 24 hour airline cancellation window. Hotels and other expenses will be billed to the Sponsor subsequent to the ministry time.
- **6.** <u>Cancellation Clause:</u> Sponsor agrees to pay Restoration Life Ministries the full balance of the minimum ministry support for a cancellation by Sponsor within 10 days of the ministry date.
